3. COMPOSITION/INFORMATION ON INGREDIENTS

Recombinant Crimean Congo Hemorrhagic Fever Virus Nucleoprotein. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: 50mM HEPES, pH7.3 and 175mM NaCl, 20% (v/v) glycerol.
