### 3. COMPOSITION/INFORMATION ON INGREDIENTS

Dengue Virus-like particles are expressed recombinantly in a mammalian cell expression system. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: physiological buffer containing 150mM NaCl and substances that are generally recognized as safe (GRAS) for *in vivo* use such as dextran, sucrose and/or trehalose.

### 4. FIRST AID MEASURES

If inhaled: Remove person to fresh air, seek medical advice if breathing becomes difficult.

**In case of skin contact:** Wash off with soap and water.

In case of eye contact: Rinse at eyewash station.

If swallowed: No treatment required




