3. COMPOSITION/INFORMATION ON INGREDIENTS

Rubella Virus-like particles are expressed recombinantly in a mammalian cell expression system. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: buffer containing 40mM TRIS-HCl pH8.0, 100mM NaCl.

If swallowed: No treatment required


