Yellow Fever virus Envelope protein is expressed recombinantly in a mammalian cell expression system. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present:

- 1. 20mM HEPES, 300mM NaCl, 0.25% Triton X-100
- 2. 20mM HEPES, 300mM NaCl, 0.25% Triton X-100
- 3. Dulbecco's phosphate buffered saline pH7.4
