### 3. COMPOSITION/INFORMATION ON INGREDIENTS

Purified Zika virus lysate derived from culture of Zika virus in LLC-mk2 or Vero cells. Sample has been heat inactivated.

Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 100µg of lysate.

Additional components present: Triton X-100 at 0.5% v/v, 0.6M KCl

## 4. FIRST AID MEASURES

If inhaled: Remove person to fresh air, seek medical advice if breathing becomes difficult.

**In case of skin contact:** Wash off with soap and water.

**In case of eye contact:** Rinse at eyewash station.

If swallowed: No treatment required

The virus in this product has been inactivated, and live virus could not be cultured from at least 1ul of lysate in a Vero cell infectivity assay. However, lysate should be handled under BSL2 conditions since the presence of infectious virus cannot be formally excluded.

Avoid contact with skin and eyes.

# Conditions for safe storage

Recommended storage temperature: -20 to -80 °C for long term.


