### 3. COMPOSITION/INFORMATION ON INGREDIENTS

BacTag is an azide-functionalized 3-Deoxy-D-manno-octulosonic acid (KDO) molecule for metabolic lipopolysaccharide (LPS) labeling of Gram-negative bacteria. Each vial contains no more than 1000µg.

Additional components present: Sterile dH<sub>2</sub>0.


