#### 3. COMPOSITION/INFORMATION ON INGREDIENTS

SARS Coronavirus Spike Glycoprotein Mosaic (S2, S2') is expressed in E. coli. Sample is of biological origin and is presented as liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: 25mM Tris-HCl, 0.4% sarcosyl, 0.25% Triton X-100 and 50% glycerol.

#### 4. FIRST AID MEASURES

If inhaled: Remove person to fresh air, seek medical advice if breathing becomes difficult.

**In case of skin contact:** Wash off with soap and water.

**In case of eye contact:** Rinse at eyewash station.

**If swallowed:** Rinse mouth with water.




