Hantaan virus Nucleoprotein is expressed in mammalian HEK293 cells. Sample is of biological origin and is presented as liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: 50mM DEA pH 10.0, 10mM NaCl, 4M urea.


