3. COMPOSITION/INFORMATION ON INGREDIENTS

Feline immunodeficiency virus core protein is expressed in E. coli cells. Sample is of biological origin and is presented as liquid in a plastic vial. Each vial contains no more than 1000μg.

Additional components present: Bicarbonate buffer, pH 8.5 + 0.02% azide.

4. FIRST AID MEASURES

If inhaled: Remove person to fresh air, seek medical advice if breathing becomes difficult.

In case of skin contact: Wash off with soap and water.

In case of eye contact: Rinse at eyewash station.

If swallowed: Rinse mouth with water.




