Diphtheria Toxin, CRM197 Mutant is expressed in E. coli cells. Sample is of biological origin and is presented in liquid format. Each vial contains no more than 1000µg.

Additional components present: 100mM NaCl, 20mM HEPES pH8.0, 10% glycerol
