Measles Virus Nucleoprotein (HEK293) is expressed in mammalian HEK293 cells. Sample is of biological origin and is presented as liquid in a plastic vial. Each vial contains no more than 1000μg.

Additional components present: Dulbecco's phosphate buffered saline (DPBS) pH 7.4. Contains traces of SDS.




