3. COMPOSITION/INFORMATION ON INGREDIENTS

Feline Panleukopenia Virus (FPLV; feline parvovirus) antigen, produced in CRFK cells. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Inactivation method: Detergent and photochemically inactivated. No specific biological hazards are known to be associated with this product. However, it should be handled with appropriate safety precautions for biological materials.

Additional components present: 50 mM Glycine Buffer, pH 9, 140 Mm NaCl.

Detergents present: <0.1% CHAPS, <0.01% SDS.

4. FIRST AID MEASURES

If inhaled: Remove person to fresh air, seek medical advice if breathing becomes difficult.

In case of skin contact: Wash off with soap and water.

In case of eye contact: Rinse at eyewash station.

If swallowed: No treatment required


