3. COMPOSITION/INFORMATION ON INGREDIENTS

Recombinant carboxyl fragment of tetanus toxin heavy chain expressed in the cytoplasm of E. coli as a properly-folded, soluble protein. Sample is of biological origin and is presented in liquid format. Each vial contains no more than 1000µg.

Additional components present: 20mM HEPES, I00mM NaCl, 10% glycerol, pH7.2.




