#### 3. COMPOSITION/INFORMATION ON INGREDIENTS

Recombinant SARS-CoV-2 S2 glycoprotein (NCBI accession number YP\_009724390.1, AA685-1211), C-terminally tagged with a dimeric sheep Fc-tag. Protein was produced in HEK293 cells and purified from culture supernatant by Protein G chromatography. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: Dulbecco's phosphate buffered saline (DPBS) pH 7.4.

## 4. FIRST AID MEASURES

**If swallowed:** No treatment required.




