2. HAZARDS IDENTIFICATION

This product is an inactivated SARS-CoV-2 viral lysate. SARS-CoV-2 is a Biosafety Level 3 microorganism when infectious. When inactivated it must be used within a Biological Safety Level 2 facility or biosafety cabinet. Please consult your institution's regulations regarding the use of this product.

Classification of the substance or mixture

Not a hazardous substance or mixture according to Regulation (EC) No. 1272/2008.

3. COMPOSITION/INFORMATION ON INGREDIENTS

Inactivated and purified SARS-CoV-2 viral lysate. Virus is purified using sucrose density gradient ultracentrifugation, disrupted in the presence of detergent and heat inactivated. Viral inactivation is verified by the absence of viral growth in tissue culture-based infectivity assays. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg. No specific biological hazards are known to be associated with this product. However, it should be handled with appropriate safety precautions for biological materials.

Inactivation method: Detergent, heat.

Additional components present: 0.5% Triton X-100 non-ionic detergent/0.6 M KCl
