Recombinant full-length Spike protein (soluble domain). The furin cleavage site (AA 682-685) has been mutated from RRAR to SRAS and the transmembrane domain and intravirion part was replaced with a glycine-serine linker and a His-tag. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS.
