#### 3. COMPOSITION/INFORMATION ON INGREDIENTS

Canine Parvovirus 2 VP2 Capsid Protein is expressed in insect cells. Sample is of biological origin and is presented either lyophilized or as liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: 20 mM Na-phosphate, pH 7.4, 30 mM NaCl, 0.01% Tween 20, 10% trehalose.


