3. COMPOSITION/INFORMATION ON INGREDIENTS

Human ACE2 was produced in HEK293 cells by transient transfection. The protein was C-terminally truncated to remove both the ADAM17 and TMPRSS2 cleavage sites. The protein was then purified from culture supernatant by Protein G chromatography. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS.
