## 3. COMPOSITION/INFORMATION ON INGREDIENTS

Influenza A virus H1N1 (Hawaii/70/2019) haemagglutinin, produced in HEK293 cells and purified from culture supernatant. This strain is part of the WHO vaccine recommendation for the Northern Hemisphere 2020/2021 season. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: Dulbecco's phosphate buffered saline pH7.4.
