Human coronavirus OC43 Spike S1 subunit, expressed in HEK293 cells and purified from culture supernatant by immobilized metal affinity chromatography, followed by dialysis. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS.
