Human coronavirus NL63 Spike protein, subunit 1 (S1). The protein was expressed in HEK293 cells and purified from culture supernatant by immobilized metal affinity chromatography, followed by dialysis. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS.
