2. HAZARDS IDENTIFICATION

3. COMPOSITION/INFORMATION ON INGREDIENTS

Purified diphtheria toxin from Corynebacterium diphtheria strain NCTC 10648; converted to inactive toxoid form. Sample is of biological origin and is presented lyophilised in a vial. Each vial contains no more than 1000µg.

Inactivation method: Formaldehyde No specific biological hazards are known to be associated with this product. However, it should be handled with appropriate safety precautions for biological materials.

Additional components present: 0.01 M Tris pH 7.5 and 0.001 M Na2EDTA.

Toxoids are made by chemical or genetic inactivation and are generally considered non-toxic. Toxicity is significantly decreased relative to the fully active toxins; however, some residual toxicity is expected. This toxoid is tested and results are described in the product Certificate of Analysis.
