SARS-CoV-2 Spike protein S1 containing D614G, L84I and N439K amino acid changes relative to the Wuhan-Hu-1 isolate. The D614G isolate has been reported to show increased virus transmissibility. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.
