3. COMPOSITION/INFORMATION ON INGREDIENTS

Recombinant full-length viral non-structural protein 7 (NSP7) is expressed in E. coli using a C-terminal His-tag. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: 20 mM Tris, pH 7.5, 300mM NaCl, 200mM imidazole, 1 mM DTT, 10% glycerol.
