Recombinant human basigin (BSG, CD147) produced in HEK293 cells and purified from culture supernatant. There is evidence that this protein can serve as an alternative entry receptor for SARS-CoV-2. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS.
