3. COMPOSITION/INFORMATION ON INGREDIENTS

SARS-CoV-2 Spike S1 RBD (AA1-223), carrying the N501Y amino acid change. This change is present in all three major global SARS-CoV-2 variants: B.1.1.7, B.1.1.28 and B.1.351. The protein was produced in HEK293 cells and purified from culture supernanant. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS.
