### 3. COMPOSITION/INFORMATION ON INGREDIENTS

Human T-cell Leukemia Virus 2 (HTLV-2) Envelope Protein produced in HEK293 cells with a TEV cleavable C-terminal sheep Fc-tag. The protein was purified from culture supernatant by Protein A chromatography and Hydrophobic Interaction Chromatography. The furin cleavage site in the Envelope protein was enhanced to increase the efficiency of cleavage in HEK293 cells. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS.
