Influenza A H1N1 haemagglutinin protein expressed in HEK293 cells and purified from cultrue supernatant. The protein carries a C-terminal T4 foldon domain, and is predominantly presented as trimers. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS.
