3. COMPOSITION/INFORMATION ON INGREDIENTS

Pre-fusion stabilized SARS-CoV-2 Spike protein of the 'New Kent'; variant B.1.1.7 containing amino acid change E484K in addition to 69-70del, Y144del, N501Y, A570D, P681H, T716I, S982A, D1118H). The protein was produced in HEK293 cells and purified from culture supernatant. The protein was stabilized using HexaPro, as described in Hsieh, Goldsmith et al. 2020. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS.
