#### **3. COMPOSITION/INFORMATION ON INGREDIENTS**

Recombinant Ross River virus antigen expressed in HEK293 cells as virus-like particles and purified by sucrose density gradients and precipitation. Virus-like particles were then solubilized in PBS containing 0.2% SDS to prevent aggregation of particles. The preparation is not particulate. Antigens in the preparation include Envelope proteins 1 and 2 and Nucleoprotein. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: PBS pH7.4, 0.2% SDS.
