## 3. COMPOSITION/INFORMATION ON INGREDIENTS

Heat-killed Vibrio cholera non-o:1, Vibrio cholera o:1, Vibrio parahaemolyticus, Vibrio vulnificus mix (0.1 mL of approximately 2% wet packed cell w/v) in dextran solution (BacTrace). Sample is of biological origin and is presented lyophilised in a vial. Each vial contains no more than 1000µg.

Additional components present: Dextran is added as a stabilizer. Non-sterile
