# 3. COMPOSITION/INFORMATION ON INGREDIENTS

Heat-killed Campylobacter jejuni cells, genus specific (BacTrace). Antigen consists of at least 4.8 x 10<sup>8</sup> cells/mL (1 mL of approximately 2% w/v wet packed cells) in dextran solution. Sample is of biological origin and is presented lyophilised in a vial. Each vial contains no more than 1000µg.

Additional components present: Dextran is added as a stabilizer. Non-sterile
