### 3. COMPOSITION/INFORMATION ON INGREDIENTS

Heat-killed Escherichia coli O103:H8 cells in dextran solution (BacTrace). Sample is of biological origin and is presented lyophilised in a vial. Each vial contains no more than 1000µg.

Additional components present: Dextran is added as a stabilizer. Non-sterile
