3. COMPOSITION/INFORMATION ON INGREDIENTS

Recombinant influenza B hemagglutinin protein. This protein is part of the 2022 WHO vaccine strain recommendation for the Southern hemisphere. The protein carries a C-terminal T4 foldon domain to assure the trimeric nature of the product. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS.
