# 3. COMPOSITION/INFORMATION ON INGREDIENTS

Recombinant norovirus-like particles. Particles are formed by expression of VP1 in HEK293 cells, and are purified from the cytoplasm using a proprietary series of density gradients. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: Proprietary buffer.
