# 3. COMPOSITION/INFORMATION ON INGREDIENTS

- 1. REC31992-NTRL-150: Recombinant SARS-CoV-2 C.37 (Lambda variant) receptor binding domain including amino acid changes L452Q and F490S relative to Wuhan-Hu-1.
- REC31876-NTRL-10.5: Human ACE2 was produced in HEK293 cells by transient transfection. The protein was C-terminally truncated to remove both the ADAM17 and TMPRSS2 cleavage sites. The protein was then purified from culture supernatant by Protein G chromatography and conjugated to horseradish peroxidase (HRP).

Samples are of biological origin and presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: DPBS, 1% BSA, Proclin.
