## 3. COMPOSITION/INFORMATION ON INGREDIENTS

Full length SARS-CoV-2 Omicron nucleoprotein gene was cloned, expressed, and purified from E. coli. Compared to wild type SARS-CoV-2 nucleoprotein, Omicron nucleoprotein has the following mutations, P13L,  $\Delta$ 31-33, R203K, G204R. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000 $\mu$ g.

Additional components present: PBS with 25mM K2CO3.
