Recombinant Norovirus GII.4 VP1 antigen produced in 293 human cells. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: 20mM Tris-HCl pH 7.8, 10mM NaCl.


