Recombinant Norovirus GII.4 VP1 Virus-Like Particles produced in 293 human cells. Norovirus VP1 structural protein is transiently expressed to form a particle without the non-structural proteins or genome. Resultant particles are totally non-infectious.

Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.
